RENTAL AND DEPOSIT PRICES: Members: \$55 non-refundable deposit + \$80 for party = \$135
Non-Members: \$95 non-refundable deposit + \$90 for party = \$185
Limit: 15 children--\$5 for each additional child

PRICES INCLUDE:

- One hour of coach directed games, half hour of party room and inflatables
- Half hour of set up time before and fifteen minutes of clean up time afterward
- Bounce house inflatables
- Tables and chairs in eating area
- Gymnastics area: sprung floor, two in-ground trampolines and foam pit (bars, beam and tumble track are excluded for safety reasons)
- Open gym time
- One Y staff attendant will coach children in one area at a time, parents are not allowed on gymnastics floor or equipment but are allowed to stay in our viewing area
